Position Summary:

 metrics in clinical practice and assessments that, collectively, support participants in
 improving their clinical-decision making, impacting health policy, and enhancing their
 leadership in anesthesiology, critical care, and health care systems.
- Positions the ASA education program to maintain ACCME accreditation along with other regulatory and/or certification requirements as necessary. Correlates education activities with MOCA part II and IV requirements of the American Board of Anesthesiology and CME mandates by state licensing. Ensures that ASA remains the educational home for its members.
