The support will include innovative simulation-based educational program development, research grant preparation, research execution and management, committee activity support, and other joint project management.

This exempt position will report to the Assistant Director, Simulation-Based Surgical Education and Training in the Division of Education.

### **Primary Responsibilities:**

- Support research grant-related efforts, including funding opportunity, identification, application preparation, fund management, post-project report creation, and dissemination.
- Support patient safety-related efforts, including creating and managing the Simulation-Based Educational Outcomes database, evaluating and managing the patient safety-related data, working with a patient safety expert group, and disseminating recommendations.
- Provide high-level, independent, and consistent support to ACS-Accredited Education Institutes (AEI) committees, Division of Education Committees, special/joint groups such as Simulator Industry Focus Group and Multi -Specialty Collaboration Group, and new committees or groups

- Contribute to various assigned projects which will involve the Research and Development processes, generate proposals supporting such initiatives, and communicate with relevant stakeholders throughout the R&D process cycle.

- Guidance of staff in relation to relevant to periodic reviews of scientific literature, engineering/technical reports, commercial publication materials, gaming and other education-focused technology trends related to surgical modeling and simulation.
