Nominees must be willing to participate in 4 live (in-person or virtual) board meetings and BOD conference calls each year. Each director serves a two (2) year term, with the opportunity to serve for a consecutive second term.

Nominees will be reviewed by the Nominating Committee to validate eligibility requirements and selection criteria. Biographical sketches of selected candidates and an IACME Election Ballot will be disseminated to the active IACME membership and all IACME members will have an opportunity to complete the IACME Election Ballot in May. Election results will then be announced to the membership.
